

INFORMATION ON THE TREATMENT OF PERSONAL DATA – NEWSLETTER

The Legislative Decree 196/2003 "protection of persons and other subjects regarding the processing of personal data" and the EU Reg. 2016/679 "Regulations on the Protection of Personal Data" (hereinafter the "Law"), govern the confidentiality, protection of personal data.

Pursuant to Article 13 of the Law, we inform you that the newsletter is sent by e-mail to those who expressly request it, filling out the form on this page and authorizing [Name of the Owner - headquarters] to process their personal data .

The provision of data is optional. The refusal to provide the data makes it impossible to obtain the newsletter service.

Purpose and duration of the treatment

The personal data provided by users are used to send newsletters containing information regarding the owner's products and services (contractual obligation and legitimate interest).

The same data will be treated as long as the interested party does not decide to unsubscribe from the newsletter service.

Data processing methods

The data collected is mainly processed mainly with IT tools.

Suitable security measures are observed to prevent the loss of data, illicit or incorrect use and unauthorized access.

Mandatory / optional nature of providing data

The provision of data is optional.

The refusal to provide the data makes it impossible to obtain the newsletter service.

The Data Controller

The "Owner" of their treatment is Nt Food S.p.A. with registered office at Via della Galeotta, 6/C, Loc. Tei, Altopascio (LU), 55011

The processing operations connected to the web services of this site take place predominantly at the aforementioned operating office and are carried out by persons authorized to do so. In case of need, for activities related to the maintenance of the technological part of the site, the data connected to the newsletter service can be processed by persons in charge of maintenance previously appointed as data processors pursuant to Article 29 of the Code and 28 of the EU Regulation.

Rights of interested parties

The law grants the interested party numerous rights that we invite you to consider carefully. Among these, we briefly remind you of the rights:

- to obtain information about the data concerning you;
to obtain the cancellation, blocking, limitation, updating, rectification, integration and portability of the Data, as well as the attestation that these operations have been brought to the attention of those to whom the Data have been communicated;
- to oppose, for legitimate reasons, to the processing of the Data;
- to lodge a complaint with a supervisory authority
- to receive in a structured format, commonly used and readable by automatic device, the personal data concerning him and to transmit such data to another Data Controller, to obtain the direct transmission of personal data from one Data Controller to the other, if technically feasible.
